

**NYCFC vs ORLANDO CITY SC 04/23/17 MATCH SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: New York City FC vs Orlando City SC Sweepstakes (the “Sweepstakes”) is open to legal residents who live within a seventy-five (75) mile radius from Yankee Stadium in Bronx, NY (the “Territory”) who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of New York City Football Club, LLC (“NYCFC” or “Sponsor”), Major League Soccer, L.L.C. (“MLS”), and Soccer United Marketing, LLC (“SUM” and collectively with Sponsor and MLS, the “MLS Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the Territory and where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: The Sweepstakes begins at 12:00 PM Eastern Standard Time on April 10, 2017 and ends at 6:00 PM Eastern Standard Time on April 21, 2017 (“Entry Period”). During the Entry Period, there is one (1) way to enter. No other method of entry will be accepted. Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household. Multiple entries received from any person, family, email address, or household in excess of the stated limitation will be void. All information submitted will be subject to and used as provided in the MLS Terms of Use and Privacy Policy, each of which can be found by visiting <http://www.mlssoccer.com/terms-service> and <http://www.mlssoccer.com/privacy-policy> (both of which are incorporated herein by reference).

Online Method: During the Entry Period, go to <http://www.contests.nycfc.com/> and click on the banners, buttons and/or links to access the online entry form for the Sweepstakes. By submitting your completed online entry form as directed, you will receive one (1) entry in the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete entries are void. Online entrants to the Sweepstakes will be given the option to receive commercial e-mails from MLS Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant’s consent to receive such e-mails and consenting to do so will not increase your chances of winning.

Facebook: During the Entry Period, in order to enter the Contest through Facebook you will need to be a registered user of Facebook. Registration is free and can be completed by visiting www.Facebook.com. Once you have registered, you may enter by visiting www.Facebook.com/newyorkcityfc during the Entry Period and follow the instructions provided to fully complete and submit the Official Entry Form. RANDOM DRAWING: The potential winner of the Sweepstakes (the “Winner”) will be selected by random drawing on or about February 8, 2017 from among all eligible entries received by the Sponsor. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period.

PRIZE: A total of one (1) prize is available to be awarded (the “Prize”). The Winner will receive the Prize which consists of: (i) two (2) tickets to New York City FC vs Orlando City SC match on April 23, 2017 at 1:30pm (the “Match”); and (ii) two (2) “New York City FC” Pen passes. Seat locations at the Match shall be determined in the sole and absolute discretion of Sponsor. The Approximate Retail Value (“ARV”) of the Prize is \$200. **All costs and expenses associated with Prize acceptance and use that are not specified herein as being provided, including but not limited to any and all transportation costs, luggage fees, meals, gratuities and other expenses incurred by accepting the Prize is the sole responsibility of Winner.** The Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). In the event the Match is cancelled, or postponed for any reason outside the control of the Released Parties (as defined below), Released Parties will have no further obligation. The Winner’s guest must be of legal age of majority in their jurisdiction of residence (and at least eighteen (18) years of age). The terms and conditions of the tickets awarded as part of the Prize will govern in the event the Match is not played due to weather conditions, an Act of God, act of terrorism, civil disturbance, work stoppage or any other reason. The Winner and his/her guest agree to comply with all applicable venue regulations in connection with the Prize. Sponsor reserves the right to remove or to deny entry to the Winner and/or his/her guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Match. Released Parties will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside its control that may cause the cancellation or postponement of the scheduled Match. Match tickets awarded as part of the Prize may not be resold or offered for resale. Any such resale may result in disqualification and Prize forfeiture, and may invalidate the license granted by the Match tickets. The Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor’s sole and absolute discretion. Sponsor reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion.

NOTIFICATION: The Winner will be notified by e-mail, mail and/or telephone, in the sole discretion of Sponsor, by the Sponsor. In the event that the Winner does not respond to any such notification within three (3) days of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries. The Winner may be required to submit his/her valid social security number (if applicable) and/or other identification to Sponsor and will be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within five (5) days of date of issuance. A disqualification will result, the Prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate Winner may be randomly selected from among all remaining eligible entries if all required documents are not properly executed and returned within the specified period of time. Refusal or return of such documents as non-deliverable or Winner’s noncompliance with these Official Rules will also result in disqualification and forfeiture of the Prize and, at Sponsor’s

sole discretion and time permitting, may cause an alternate Winner to be selected from among all remaining eligible entries.

Entries generated by a script, macro or other mechanical or automated means or by any means which subvert the entry process will be disqualified. Released Parties are not responsible for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the Prize or in any Sweepstakes-related materials, or the cancellation or postponement of the Match. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this Sweepstakes or downloading materials from or use of the website.

Any attempt to deliberately damage the content or operation of this Sweepstakes is unlawful and subject to legal action by the Sponsor, the other MLS Entities and/or their respective agents. Sponsor and the other MLS Entities shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable

laws relating to the Sweepstakes, and to resolve all disputes in their sole discretion. Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. All disputes will be resolved under applicable U.S. laws in the County of New York, state of New York without giving effect to choice of law or conflicted law principles (whether of the state of New York, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state of New York. Sponsor's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision.

The Sponsor and the other MLS Entities, as applicable, reserve the right, in their sole discretion, to cancel or suspend the Sweepstakes for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes. In the event of cancellation, Sponsor may elect to identify the Winner and award the Prize by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation.

The "Authorized Account Holder" is defined as the natural person to whom the applicable Internet service provider or other organization (such as a business or educational institution) has assigned the e-mail address for the domain associated with the submitted e-mail address. Sponsor reserves the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.
